- Age limit as on 25.03.2011: 30 years for General. Age relaxation to the extent of Service in ONGC in respect of departmental candidates/ contractual paramedics candidates/ Apprenticeship period in ONGC in respect of Ex Apprentices.
- After initial screening, the candidates will be required to undergo written test, medical fitness test and interview in any sequence as decided by ONGC. The written test is likely to be held during **3rd week of April, 2011.**
- The SC/ST certificate / OBC caste certificate (with non-creamy layer), if applicable, should be valid and in the format prescribed for appointment to posts under the Government of India. Only caste certificates issued by the Competent authority i.e., District Magistrate / Additional District Magistrate / Collector / Dy.Commissioner / Additional Dy. Commissioner / Dy. Collector / First Class Stipendiary Magistrate / Sub Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner (not below the rank of I class Stipendiary Magistrate / Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate / Chief Revenue Officer not below the rank of Tahsildar / Sub Divisional Officer of the area where the candidate and / or his family normally resides or any other authority as decided by Govt. of India, are acceptable.
