Kind attention is drawn to the Arbitral Award dtd. 20.02.15/08.04.15 passed against ONGC in Arbitration matter between M/s JSIW and ONGC in the contract No. DLH/OES/2PLRP/AMD-MHN/X11MC08002/2008 and DLH/OES/2PLP-Ank/X11MC08001/2008 for "Two Pipeline Replacement Project (2PLRP)" for Ahmedabad & Mehsana Asset and "Two Pipeline Project (2-PLP)" for Ankleshwar Asset respectively. The said award has been challenged by ONGC before the Delhi High Court.

NITI Aayog vide Office Memorandum dtd. 05.09.2016 has issued instructions to pay 75% of the awarded amount and interest on such amount till date of payment which shall constitute the total eligible payout. The eligible payout shall be released against the Bank Guarantee provided by the contractor.

The said award has been challenged by ONGC before the Hon'ble District Civil Court of Surat by filing its application dated 15.11.2016.

NITI Aayog, Govt of India, New Delhi, vide Office Memorandum dtd. 05.09.2016 (Copy attached) has issued instructions to pay 75% of the awarded amount and interest on such amount till date of payment which shall constitute the total eligible payout.
