#### **Eligibility Criteria:**

**Educational Qualification-** Atleast a B.Tech /M.Tech /M.Sc. with specialisation in Mechanical/ Electrical /Electronics/Production /Energy. Ph. D in Mechanical / Electrical / Electronics/Production /Energy including Solar, is desirable

**Experience Requirement-** Minimum 10 years’ experience in Solar Thermal related Projects and/or Research activities

**Candidates with other expertise need not apply.**

**Terms of Engagement:** The Expert will be initially engaged for a period up to 1 year. The tenure of engagement may be extended on need basis for further periods, subject to project requirement and satisfactory performance of the Expert engaged. However the total duration of engagement will be limited to a maximum of 3 years.

**Place of Posting:** Delhi
